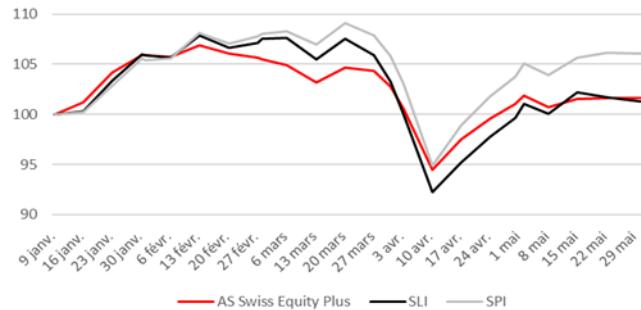
Investment Strategy
